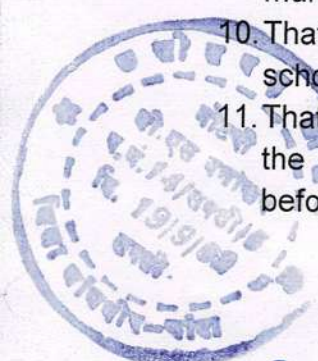
AFFIDAVIT

6. That the school will not open classes under CBSE pattern particularly class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and the provisions contained in the affiliation & examination byelaws.
8. That the school will ensure compliance of all statutory requirements like EPF, ESI, and labour Laws etc. with respect to the school and staff of the school.
9. That the school will ensure that Building Safety, Fire safety, Water Safety, health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.

11. That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation byelaws are available with the school before starting classes.






